I got presenters on the Musical Instrument Museum, Phoenix Theatre Company, Commemorative Air Force, Southwest Airline Pilot, Phoenix Herpetological Sanctuary, Guide Dogs of the Desert plus others.

Vice-President's Report – Vacant position, volunteer needed. – report provided by Dave Oman.

The October 4th meeting presentation was provided by Steve Hoza. Steve is a recognized authority on the history of World War II in Arizona. He presented a PowerPoint program of the history of the German's internment in Arizona. He also had several artifacts on display.

More on Steve Hoza from Al Stimac - Steve Hoza presented the history of the German's internment in Arizona and showed artifacts from the prisoners. Arizona was the home to 26 camps including the one at Papago Park. Papago POW

Camp was one of the largest in Arizona. The camp at Papago was for naval personnel only like U-Boat Captains, their crews, merchant mariners and land-based naval personnel that were captured in North Africa. In 1994 Hoza took out ads in Germany so that he could contact ex-POWs. He received about 100 responses. He flew to Germany to interview them and some came to Phoenix to tell their stories. Virtually all had not told of their experience to anyone and as a result gave numerous artifacts and source documents to Hoza. As a result some became friends and frequent visitors.

Hoza is the author of the book "PW: First Person Accounts of German Prisoners of War in Arizona." It is a collection of stories and letters told by these POWs stationed in Arizona. The camps were self-contained towns. They had their own hospitals, fire department. The prisoners put out their own newspaper. They had their own power plants, sewage system. Hoza knew prisoners who worked at the Biltmore Hotel as gardeners, they worked in laundries in downtown Phoenix. They worked on the irrigation canals. They were paid an hourly wage to maintain the irrigation canals.

Hoza also related the Not-So Great Escape from the Papago POW Camp. More than two dozen Germans broke out through a tunnel that took them three months to dig. The men decided to take along a kayak they built and carried it out in pieces. They saw a map showing a flowing Gila River and decided that would be their escape route, but were forced to walk after realizing there were only puddles in the river. All were captured in less than two months. Hoza said two made it as far as 10 miles from the Arizona-Mexico border. Hoza said the POWS looked at it as more as almost a fraternity prank than anything else. They really didn't think that they could go anywhere, but they had to try.


